Per HB84's definition of a "Failing School" (see Section 4(3)), a school that meets one of five classifications is considered failing. These classifications are represented in the chart above as follows:

- 1 A school "that is listed in the lowest ten percent of public K-12 schools on the state standardized assessment in reading and math"
- 2 "A public K-12 school that is labeled as persistently low-performing by the State Department of Education, in the then most recent United States Department of Education School Improvement Grant application"
- 3 A school "that has earned a grade of 'F'" on the school grading scale, once it is implemented pursuant to Section 16-6C-2
- 4 A school that has earned "three consecutive grades of 'D'" on the school grading scale, once it is implemented pursuant to Section 16-6C-2
- 5 A school that is designated by the State Superintendent of Education as failing
